The Direct Debit Guarantee

If an error is made by Addaction or your Bank or Building Society, you are guaranteed a full and immediate refund from your branch for the full amount paid. You can cancel a Direct Debit at any time by writing to your Bank or Building Society. Please also send a copy of your letter to Addaction.
